Attached is the Profit & Loss Statement for the first six months of 2018 and the Balance Sheet depicting the financial condition of the District as of July 31, 2018. During the period, operating revenues exceeded expenses by \$5,761.43. Expenses for *Scorecard* during the period exceeded revenue by \$1,363.20. In addition to operating revenue, the District has received \$3,414.00 from the units hosting regional tournaments to be applied to future NABC. Currently, the accumulated funds for NABC total \$18,424.00.

Subsequent to the end of the reporting period, the district has received \$20,576.07 in Grass Roots Funding from the ACBL.

The District remains in a strong financial position.
