On July 6, your Board of Directors met via Zoom. The following were the main points of the meeting:

> District Director's Report: Paul Cuneo updated us regarding ACBL actions. (See his report in this issue.)

Financial Report: D16 continues to be in a strong financial position and is in good standing to continue its mission.

Director's Corner: Melody Euler conducted Zoom lectures for the past five months giving the club directors the opportunity to refresh their director skills before going back to F2F bridge. Thank you, Melody!!! Thanks also to Kevin Perkins and Scott Humphrey for serving as lec-

Education: The D16 0-20 and 99er Nite Club games have been very successful. We have also enjoyed great attendance for the Lecture Series averaging 90 attendees each lecture.

Membership: Night and Weekend Games--The goal is to get people who are working or have daytime commitments involved in the game. Austin has been holding these games as a test. Contact Sandy the form needed in order to participate. There are drawings for free plays and discounted coupons. This is a part of the membership growth and retention program.

I/N: Sam Khayatt is the new I/N Coordinator replacing **Stu Nelan** since he recently resigned. We are very grateful for Stu's work on the board as he provided a more effective structure for communicating and sharing best practices throughout the district. We welcome Sam who is a Star Award recipient and bridge teacher!

NAP: The D16 NAP finals will be held in conjunction with the San Antonio sectional January 13-16, 2022, at the Drury Plaza Stone Oak. No unit qualifications are needed and qualifications can be achieved anywhere All flights will play January 15-26.

Austin 2021 NABC: All NABC games will be on the 4th floor, all Regional Pairs and I/N games on the 3rd, and Daylight team games on the 2nd, making a great layout for events. Hotel reservations opened and the ACBL reported they were on track for 6500 tables. Parking options are still being explored. More options will be available 30 days out.

Scorecard Review: Electronic vs Printed. A two-year study was presented with recommendations. An ad hoc committee was appointed to gather more data in order to clarify the differences between electronic and printed issues.

Marketing/Publicity: Marketing at this point is done on an on-demand basis. A Policies and Procedures Man ual is near completion which will include job descriptions. Rachell Jackson and team are doing an exceptional job. The Facebook D16 group page now has 528 members.

Mexico Agreement: An official agreement was approved by the D16 BoI and Unit 205. Going forward, the Puerto Vallarta Regional will be handled as other Regionals through out the District. As a result, the District terminated the previous profit-sharing agreement with Unit 205; all profits will belong to Unit

It has been a difficult year and a half for all of us, but in spite of the pandem ic, your board has implemented several new initiatives which improve our district's bridge community. Increasing and retaining membership is the # priority since nationwide numbers continue to decline. Please share your ideas with us to help our district grow! Let's play more bridge!

Our clubs and players are returning to faceto-face play. However, table counts for face-to-face clubs are significantly lower than pre-pandemic. Total table count for face-to-face and online bridge has been declining since early this year as people are freer to travel and pursue other activities. I'm optimistic that we'll see rising table counts this fall in our face-to-face clubs.

You've probably seen the notice that all tournaments scheduled in August that require ACBL directors will be cancelled. It's unfortunate that the Delta variant has caused a surge in so many states. I want to encourage everyone to be cautious and stay

ACBL's financial situation remains strong despite lower revenue from both clubs and online tournaments. Expenses were lower than budget for the 1st half of 2021 and net income is higher.

The ACBL Board has been meeting frequently and concluded its regularly scheduled July meeting on the 16th. The most important actions during that board meeting revolved around defining the plan for the transition back to face-to-face bridge. The Strategic Committee, which I chair, has been discussing this topic since last fall. We agreed some key elements with managements which are being rolled out to the clubs in August. Among these are:

Elimination of the masterpoint multiplier for Virtual Club games beginning August 2

Suspension of "special weeks" for Virtual Clubs also beginning August 2

Expanding the Support Your Club games with the addition of several masterpoint limited games throughout the day for our newer players. As face-to-face clubs reopen they are offering fewer games online and having trouble getting their masterpoint limited games to make face-to-face.

Another important action by the Board was to adopt a new version of the Code of Disciplinary Regulations. The last major change was in 2017. This change is primarily around online bridge but cleans up the structure of the code in all areas. Sadly, online cheating continues to be an issue and pairs from our district have received some severe sentences recently.

The ACBL Educational Foundation is preparing to launch a new initiative to teach bridge to youth named Bridge Whiz. It is based on a very successful program in the Seattle area that uses Peachjar.com to reach parents. It is called Bridge for Youth. The Foundation has recruited teachers who will teach online classes to students interested in learning to play bridge. The basic program has 20 lessons and will be free to students. We're planning an October launch.

ACBL DISTRICT 16 REVISED COVID-19 TOURNAMENT VACCINATION POLICY **EFFECTIVE AUGUST 1, 2021**

The District 16 Board of Directors has adopted the following policy for all Sectional and Regional Tournaments held anywhere in the District, effective immediately:

- 1. No one shall be permitted to play in any tournament unless that person has provided proof of vaccination against the Covid-19 virus. There are NO exceptions.
- 2. A vaccination card or a photocopy of a vaccination card is acceptable proof. If proof can be provided in some other manner it may be accepted. An affidavit or other declaration by a prospective player is NOT sufficient.
- 3. Each Tournament Chair shall designate an Event Safety Coordinator. If there is no Tournament Chair the Unit President or District President shall make the designation.
- 4. The Event Safety Coordinator shall be responsible for ensuring that only vaccinated people participate in the tournament. To the extent possible, the Event Safety Coordinator should also require proof of vaccination from non-players before granting them entry to any playing area.
- 5. The Event Safety Coordinator may implement additional safety protocols at their discretion, such as providing masks or hand sanitizer, but may not require anyone to wear a mask. However, the Board of Directors of the tournament sponsor (the host Unit or District) may mandate masks.

SUGGESTIONS FOR TOURNAMENT CHAIRS

No one wants to turn away a player, so tournament flyers posted on a Unit, District or ACBL website should include a statement that only vaccinated people may play in the tournament.

To minimize disruption to the tournament schedule, particularly on the first day of a tournament, consideration should be given to accepting proof of vaccination in advance of the tournament.

FURTHER INFORMATION

This policy will remain in force until modified or rescinded by the District 16 Board of Directors. Tournament Chairs and Event Safety Coordinators who have questions should contact David Pearlman at davidjpearlman@gmail.com.

ACBL has informed us that all August Sectionals have been cancelled. However units are being permitted to host a downgraded Sectional using local directors if we choose.

So, Unit 172 has decided to host a downgraded Sectional with this format at Fiesta Bridge Club, San Antonio, Tx. Other Units may follow. These sectionals will be noted as "downgraded" at The ACBL tournament page.

Also, Unit 172, has decided to cancel the September New Braunfels Sectional due to extenuating circumstances.

ACBL Board of Governors/Advisory Council Report by Betty Starzec

(As you can tell from the title, the Board of Governors voted to change its name to reflect more clearly the actual function of the Board. It was voted that the name will be the Advisory Council. This was done toward the end of the BoG meeting.)

BoG members should have been present during the Membership Meeting which took place one hour prior to the start of the BoG meeting. At the Membership Meeting the ACBL Management Report for Summer 2021 was presented. Significant activity included that the membership was down 9% from 2020. Over 2,300 clubs have renewed their sanctions for 2021. More than 85% of the previously sanctioned clubs have renewed and this number continues to slowly grow.

Virtual Club Games table counted have leveled off and begun to drop at a higher rate than the growth of face-to-face play. As of the end of June, 886 clubs have returned to face-to-face play. The August online tournament will be the last online tournament through 2021.

Information Technology Department has developed the initial release of the pre-registration application for members to register for upcoming face-to-face tournaments. This application will be released in planned releases now through September before the Fall 2021 NABC. Technology for uploading games has been rewritten and currently being tested. Migration from the old DB2 platform has begun.

Guest Membership Program currently has 800+ active Guest Members and 640 have converted so far to a full membership.

Alzheimer's Longest Day raised \$929,000 in 2020. As of June 30, 2021 \$630,800 has been raised.

ACBL's new online *Intro to Bridge* by Patty Tucker began in June. Three separate lesson streams provided to 70 participants were sold out within days. Cost is \$50.00. More streams are being offered in July and September 2021 with future sessions scheduled in 2022.

ACBL's financial picture is very positive due to continued success of online game play.

Mask policy is constantly being updated but it is felt that ACBL is not bound by HIPAA but will be reviewed. Currently full vaccinated players are not required to wear a mask.

Doug Couchman, Chair BoG, listed all the items that were voted on by the ACBL Board of Diectors. He promised that the BoG would receive information on the items up for review/vote prior to the BoG meetings in the future so the members would be able to formulate possible responses. Among the items were: addressing needs in going back to face-to-face play, discussion on requirements for everyone in play to have a membership number (tabled), technical changes related to Bylaw changes in Board of Governors, CDR clean up and clarifications, and eliminate reimbursement for hotel and per diem for Directors between their meetings and the BoG meeting (passed, effective after Austin.)

Doug addressed under Old Business the discussion of a possible name change. After debate and vote, the new name of the Board of Governors is the Advisory Council.
